TERMS OF AGREEMENT

3. WE WILL KEEP OUR CHAPTER ACTIVE IN THE AMERICAN-SPEED.COM COMMUNITY VIA WEB COMMUNICATIONS.
4. WE WILL HOLD REGULAR MEETS FOR OUR CHAPTER.
5. WE WILL PARTICIPATE IN EVENTS SUCH AS CAR SHOWS.

9. WE ARE AN OPEN COMMUNITY AND WILL NOT DISCRIMINATE AGAINST ANYONE ON THE BASIS OF RACE, ETHNICITY, NATIONALITY, GENDER, SEXUAL ORIENTATION, RELIGION, OR POLITICAL AFFILIATION.
10. WE ARE A COMMUNITY FOR ALL CAR ENTHUSIASTS AND WILL NOT DISCRIMINATE AGAINST ANYONE ON THE BASIS OF THEIR VEHICLE OR LEVEL OF KNOWLEDGE AND EXPERIENCE IN WORKING WITH CARS.
